If you have a claim against someone else, mark the Third Party Claim section on the Reply and complete a Third Party Claim and file both forms at the Nunavut Court of Justice.

IF YOU FAIL TO REPLY WITHIN 30 DAYS, JUDGMENT MAY BE ENTERED AGAINST YOU WITHOUT FURTHER NOTICE.

IF YOU DO NOT UNDERSTAND THE LANGUAGE OF THIS DOCUMENT, YOU MUST CONTACT THE CLERK WITHIN 25 DAYS (30 DAYS IF YOU LIVE AND CARRY ON BUSINESS OUTSIDE NUNAVUT) OF RECEIPT OF THIS DOCUMENT.
