### CONDITIONAL SENTENCE ORDER

- \_\_\_ 2. You must **appear before the Court** when required to do so.

- \_\_\_ 6. You must **notify** the Court or your supervisor in advance of any change of name or address or change of employment.

- \_\_\_ 8. You must **reside**:

- \_\_\_ 9. You must **abstain** absolutely from the possession or consumption of any intoxicating substances (including alcohol) unless the substance is lawfully prescribed by a physician.
- \_\_\_ 10. You must not be present in any residence where alcohol is being served.
- \_\_\_ 11. You must seek or maintain **employment** and provide a monthly report to your supervisor on your efforts to do so.
- \_\_\_ 12. You must attend such **educational or recreational programs** as may be directed by your supervisor and not be absent from these programs without the permission of your supervisor.
- \_\_\_ 13. You must undergo an **assessment**: (psychological, alcohol). You must attend **counselling** (family counselling, anger management counselling, addictions counselling, alcohol counselling, \_\_\_\_\_ counselling) as directed by your probation.
- \_\_\_ 14. You must perform \_\_\_\_\_ hours of **community service work** as and when directed to do so by your conditional sentence supervisor (or his or her lawful designate) and to his or her satisfaction, to be completed by \_\_\_\_\_.

\_\_\_\_ 20. You must make reasonable efforts to **provide for the support and care** of \_\_\_\_\_ and provide your supervisor with a monthly report on your efforts to do so.

From now until midnight of the \_\_\_\_\_ day of \_\_\_\_\_ , 20\_\_\_\_ you must **remain inside your residence** or within 10 meters of your residence 7 days a week except for two hours a day between the hours of \_\_\_\_\_ and \_\_\_\_\_ daily, except where you have obtained the prior written permission of your supervisor to be away from your residence outside these hours. Where permission is given by your supervisor, you must carry the letter of permission on your person when you are away from your residence and produce it immediately upon the demand of a peace officer or your supervisor.

\_\_\_\_ 22. At any time during periods of your confinement, you must present yourself to the front door of your residence upon the request of a peace officer or your supervisor.
